

MINUTES Town Council Regular Meeting Tuesday, February 4th, 2025 at 6:00 pm 2909 Platt Springs Road, Springdale, SC 29170

The media and public were duly notified of the date, time, and place of this meeting.

4. Old Business

- A. **Ordinance O-24-06MA;** AN ORDINANCE AMENDING THE TOWN OF SPRINGDALE ZONING MAP; FOR TMS# 005632-03-006 TO BE REZONED FROM R-1 SINGLE-FAMILY RESIDENTIAL TO C-1 GENERAL COMMERCIAL. (2nd Reading). Councilmember Reeley made a motion to maintain the current zoning of the property, with a second from Councilmember Fecas. The motion passed unanimously.

She is waiting to hear from Lexington County Administrator Lynn Sturkie. She stated the recent planning and zoning training hosted at Town Hall was a success, with over 40 participants from Lexington and Richland Counties.
