

MINUTES

Town Council Regular Meeting October 4, 2016 at 6:00 p.m. Council Chambers – Springdale Town Hall, 2915 Platt Springs Road

The media and public were duly notified of the date, time, and place of this meeting.

MEMBERS PRESENT: Mayor Michael Bishop, Mayor Pro Tem Ricard, Councilmembers Hallman, Wilkerson, Peters, Reeley, and Fecas, Town Administrator Jeff Stilwell, and Town Attorney Danny Scott.

MEMBERS ABSENT:

I. Call to Order

Mayor Bishop called the meeting to order at 6 P.M. A quorum was present. Councilmember Hallman provided the invocation. Mayor Bishop led the Pledge of Allegiance.

II. Consent Agenda

- A. Approval of Agenda. Council approved the agenda without objection.
- B. Approval of Minutes. Council adopted the minutes from the September 6, 2016 Regular Meeting and the minutes from the September 19, 2016 Work Session without objection.

III. Proclamations and Mutual Agreements

- A. Consideration of Proclamation P-16-06: Concerning the 34th Annual National Night Out. Council, on motion of Councilmember Reeley, seconded by Councilmember Wilkerson, voted unanimously to pass Proclamation P-16-06 recognizing the 34th Annual National Night Out.
- B. Consideration of Proclamation P-16-07: the Law Enforcement Assistance and Support Agreements with Town of Lexington Police Department. Council, on motion of Councilmember Wilkerson, seconded by Councilmember Hallman, voted unanimously to pass Proclamation P-16-07: the Law Enforcement Assistance and Support Agreements with Town of Lexington Police Department.
- C. Consideration of Proclamation P-16-08: the Law Enforcement Assistance and Support Agreements with the City of West Columbia Police Department. Council, on motion of Councilmember Fecas, seconded by Councilmember Peters, voted unanimously to pass Proclamation P-16-08: the Law Enforcement Assistance and Support Agreements with the City of West Columbia Police Department.

IV. Chief's Report

A. Chief's Report. Chief Cornett was unavailable to make his monthly report due to the National Night Out event running concurrently with the Town Council meeting. Administrator Stilwell discussed employment in the Police Department and updated Council on speed trailers in Town.

V. Old Business

A. Consideration of Ordinance O-16-07: Amending the Code of Ordinances, Section 14, Nuisances; modifying Subsection 4 (A and B) governing Unsanitary, Unsightly, and Unsafe Conditions. Councilmember Reeley asked about enforcement and Mayor Bishop stated that the Town would make the initial determination and bring in Lexington County to confirm if the Town's determination was challenged. Mayor Bishop stated that this would only apply to dead trees or limbs that endanger property. Councilmember Hallman, seconded by Councilmember Wilkerson, unanimously voted to give second reading to Ordinance O-16-07: Amending the Code of Ordinances, Section 14, Nuisances; modifying Subsection 4 (A and B) governing Unsanitary, Unsightly, and Unsafe Conditions.

VI. New Business

A. Discuss Town sponsorship of Springdale Elementary Fund Run. Administrator Stilwell discussed the Town's past sponsorship of \$250 for Fund Run. Councilmember Fecas discussed the use of the funds and encouraged Council to donate. Council, on motion of councilmember Fecas, seconded by Councilmember Peters, voted unanimously to give \$250 to support the Fund Run for this year.

VII. Reports

A. Town Council Reports. Mayor Bishop discussed an email he received from a citizen about a sidewalk on Tarrytown Lane and asked for an update on the Kitty Hawk Drive sidewalk. Administrator Stilwell answered DOT is to begin property acquisition next summer. Mayor Bishop also mentioned that Tom Slickman from Midlands Technical College had done the final reading of the scholarship made available by the Town and final changes to the scholarship. Council discussed work on repaving the parking lot at the Springdale Shopping Center. Mayor Pro Tem Ricard asked if the work had been completed in order to provide the shopping center with the grant funds and Administrator Stilwell responded that the shopping center had not completed the resurfacing to the Town's satisfaction in order to qualify for the grant funds.

B. Administrative Report. Administrator Stilwell informed Council that Food Truck Friday for October may be postponed due to the upcoming hurricane. He also encouraged everyone at the meeting to attend National Night Out afterwards. Administrator Stilwell further discussed redoing the medians and engaging a landscaper to assist.

C. Public Works Director's Report. Public Works Director Ancik's report was received as information by the Council. Council discussed the new truck purchased for the Town.

VIII. Appearance by Citizens

No public comment was made as no one had signed the form to speak.

IX. Adjournment

Council, on motion of Councilmember Reeley, seconded by Councilmember Hallman, voted unanimously to adjourn the meeting at 6:17 P.M.
