**MINUTES**

Town Council Special Meeting

March 19, 2018 at 6:41 p.m.

Council Conference Room – Springdale Town Hall, 2915 Platt Springs Road

MEMBERS PRESENT: Mayor Michael Bishop, Mayor Pro Tem Ricard, Councilmembers Hallman, Wilkerson, Reeley, Peters, and Fecas, and Town Administrator Ashley Watkins.

MEMBERS ABSENT: Town Attorney Danny Scott.

**I. Call to Order**

Mayor Bishop called the meeting to order at 6:41 P.M. A quorum was present.

**II. Consent Agenda**

Council approved the agenda without objection.

**III. New Business**

A. Consideration to allow construction of Single Family Home at 1065 Crest Drive, Springdale. Administrator Watkins provided Council with information concerning the home that Hurricane Construction plans to build at 1065 Crest Drive. Council discussed the building of the home at this location. Council, on motion of Councilmember Fecas, seconded by Mayor Pro Tem Ricard, voted unanimously to allow the construction of a Single Family home at 1065 Crest Drive.

A. Adjourn to Executive Session to discuss a personnel matter relating to appointed positions. Council, on motion of Councilmember Reeley, seconded by Councilmember Fecas, voted unanimously to enter Executive Session at 6:58 P.M.

**V. Return to Open Session – Action may be taken regarding matters discussed in Executive Session**

A. Return to Open Session. Council, on motion of Councilmember Fecas, seconded by Councilmember Reeley, voted unanimously to return to open session at 7:50 P.M. Mayor Bishop stated that no action was taken during Executive Session. Councilmember Fecas made a motion to remove the judge and Town Attorney at the end of the Fiscal year that was seconded by Councilmember Peters. Councilmember Reeley stated that he felt the removals needed to be motioned and voted on separately, thus, no vote took place on the original motion. Councilmember Fecas withdrew the original motion. Council, on motion of Councilmember Fecas, seconded by Councilmember Peters, voted to remove the current Town Judge and appoint a new judge at the end of the fiscal year. Mayor Bishop, Mayor Pro Tem Ricard, and Councilmembers Peters and Fecas voted in favor. Councilmembers Reeley and Wilkerson opposed. Council, on motion of Councilmember Peters, seconded by Mayor Pro Tem Ricard, voted to remove the Town Attorney and appoint a new Town Attorney at the end of the fiscal year. Mayor Bishop, Mayor Pro

Tem Ricard, and Councilmembers Peters and Fecas voted in favor. Councilmembers Reeley and Wilkerson opposed.

**VI. Adjournment**

Council, on motion of Councilmember Fecas, seconded by Councilmember Wilkerson, voted unanimously to adjourn the meeting at 7:55 P.M.
