

MINUTES

Town Council Regular Meeting
July 7, 2014 at 6:00 p.m.
Council Chambers – Springdale Town Hall, 2915 Platt Springs Road

The media and public were duly notified of the date, time, and place of this meeting.

MEMBERS PRESENT: Mayor Michael Bishop, Mayor Pro-Tem Manos, Councilmembers Wilkerson, Reeley, Hallman, Ricard, Interim Town Administrator Joe Boyes, and Town Attorney Danny Scott.

MEMBERS ABSENT: Councilmember Peters.

I. Call to Order

Mayor Bishop called the meeting to order at 6 p.m. A quorum was present. Councilmember Hallman provided the invocation. Mayor Bishop led the Pledge of Allegiance. The agenda was approved without objection.

II. Approval of Minutes

A. The minutes from the June 3, 2014 meeting were approved as submitted.

III. Business License Denial Appeal Hearing – Traveler's Inn (2200 Airport Blvd.)

A. The hearing was continued to a future time.

IV. Unfinished Business

A. Strategic Planning Initiative. The Strategic Planning Initiative was received as information by Council.

V. New Business

- A. Consideration to authorize an Intergovernmental Agreement Between the Town of Springdale and the SC Department of Juvenile Justice for the Detention of Juveniles. Council, on motion from Councilmember Wilkerson, seconded by Councilmember Hallman, voted unanimously to approve an intergovernmental agreement between the Town of Springdale and the SC Department of Juvenile Justice for the detention of juveniles.
- B. Springdale Farmers Market. Council, on motion from Mayor Pro Tem Manos, seconded by Councilmember Ricard, voted unanimously to approve a motion authorizing the use of Felton C. Benton Park periodically throughout the summer for Town-sponsored Farmers Markets at no cost to vendors.
- C. Consideration of O-14-05: An Ordinance Amending the Town of Springdale Zoning Ordinance Sections 2.4.2, 2.8.3, and 3.3. Council, on motion from Mayor Pro Tem Manos, seconded by

Councilmember Wilkerson, voted 5-1to approve the Ordinance amending the Town of Springdale Zoning Ordinance Sections 2.4.2, 2.8.3, and 3.3, with Councilmember Reeley voting against.

- D. Funding of FY15 Capital Purchases. Council, on motion from Mayor Pro Tem Manos, seconded by Councilmember Reeley, voted unanimously to authorize the administrator to purchase with cash reserves the two Police vehicles and one Public Works truck that were included in the fiscal year 2015 budget.
- E. Sunday Alcohol Sales Referendum Issue. Council, on motion from Mayor Pro Tem Manos, seconded by Councilmember Hallman voted 5-1 not to move forward on the referendum allowing Sunday alcohol sales, with Mayor Bishop voting against.

VI. Reports

A. Town Council Reports. The Mayor reported that he and Councilmember Peters attended the Farmers Market in Felton C. Benton Park and that he, along with Councilmember Peters and Mayor Pro Tem Manos, attended the grand opening of the Elephant Trunk store. Mayor Bishop helped with a recycling event and announced the Town will look into having a similar even in October. Mayor Bishop also spoke with developers and attended several meetings. He further mentioned looking for a means to honor the Doolittle Raiders. Councilmember Ricard announced that the Council of Governments awarded the Town of Springdale a grant totaling \$142,000 to install sidewalks on Kitty Hawk Drive.

- B. Administrator's Report. Administrator Boyes provided updates on a Supreme Court decision affecting local government agendas and the Platt Springs Road Lighting Project. He stated that the lights are on track to be installed by November. Adding to Councilmember Ricard's report, Administrator Boyes stated that the Town will know by October how soon they can proceed with the Kitty Hawk Drive sidewalk installation. He further gave an update on construction in Parrish Plantation.
- C. Public Works Director's Report. Public Works Director Ancik announced the hiring of a part-time employee and requested permission from the Council to set up an interest meeting for the Beautification Committee the following Tuesday. The Mayor announced that the interest meeting would take place on Tuesday, July 15.
- D. Chief's Report. Chief Cornett reviewed his monthly report and statistics with the Council.

VII. Public Comment

Mr. George Capps asked the Town to look into the landscaping at the I-26 off-ramp and the creation of a facility that residents could bring used motor oil to for recycling. Administrator Boyes stated that the landscaping project was included in areas the Beautification Committee would address. Mayor Bishop commented that more recycling programs are being considered. Dr. Tom Siler introduced himself to Council as a candidate for the Lexington County School District 2 Superintendent position.

VIII. Executive Session

Council, on motion of Councilmember Reeley, seconded by Mayor Pro Tem Manos, voted to go into executive session at 6:49 pm to discuss a legal matter. Council, on motion of Councilmember Reeley, seconded by Mayor Pro Tem Manos, voted to come out of executive session at 7:40 pm. No action was taken during executive session.
