Springdale Planning Commission Regular Meeting Tuesday, November 17th, 2020 at 6:00 pm

I. Call to Order

Chair Jordan called the meeting to order at 6:00 pm. A quorum was present. Member Hutchinson provided the invocation. Chair Jordan led the Pledge of Allegiance.

IV. **Public Hearing**

A. Zoning Text Amendment Request for Section 4.3.5(A), Commercial and Recreational Vehicle. Administrator Watkins gave background information on the text amendment request, stating that Council discussed the ordinance during the September 21st Work Session and an ordinance amendment was presented during the October 6th Regular Meeting. She stated that multiple complaints from residents concerning commercial vehicles have been received and after reviewing the ordinance, Council felt it was too restrictive on commercial vehicles. There was a brief discussion of the types of vehicles that are affected by the ordinance. Chairman Jordan stated that issues with commercial vehicles is not a new problem in Springdale and reflected on semi-trucks being parked along Wattling Road. Chairman Jordan asked what the process would be for violations to the ordinance. Administrator Watkins stated that violations will be referred to Code Enforcement who would issue a warning, follow up, and then issue a citation if the violation isn't corrected.
